The RP, in parallel, has filed an application before the NCLT, Mumbai for extension of corporate insolvency resolution process period by 90 days in terms of Section 12 of the Code, 2016. In the event that the extension is granted, these timelines may be modified with approval of the committee of creditors and shall be accordingly communicated to prospective resolution applicants.
