- 2 Interest of Rs 44755791/ in Claim of Custom not considered as the custom department has yet to submit copy of Bonds executed by the Corporate Debtor. Principal amount of Custom Claim considered after deducting BG limit utilized of Lavasa Corporation Ltd of Rs 29827746/ which has been considered in claim of Lavasa in Financial Creditors. If the same is considered here in operational Creditors then the same amount of Rs 29827746/ is to be reduced from the claim of Lavasa Corporation Limited otherwise there will be dual claim of Rs 29827746/
- 3 MSEDCL-Electricity Bills from february 19 and onwards cannot be accepted in Claim. However the same has been included by way of note in Information memorandum.
- 4 GST department has raised a demand of Rs 57.96 Lakhs but they have not yet filed their claim. However the same has been included by way of note in Information memorandum.
